ADDENDUM NUMBER 1

REQUEST FOR STATEMENT OF QUALIFICATIONS (RFSQ) FOR A JUSTICE SUPPORT SERVICES MASTER AGREEMENT (JSSMA) BID #JC-110424-J1

The County of Los Angeles, Justice, Care and Opportunities Department (JCOD) issues this Addendum Number 1 to the Request for Statement of Qualifications (RFSQ) for a Justice Support Services Master Agreement (JSSMA) released on November 4, 2024 to incorporate revisions to the solicitation.

REVISIONS

1. **RFSQ, Section 5.0 NOTIFICATION TO VENDORS, Subsection 5.2, Contact with County Personnel**, is deleted in its entirety and replaced with the following:

"5.2 Contact with County Personnel

"Any contact regarding this RFSQ or any matter relating thereto must be in writing and e-mailed to:

JCOD Solicitations Team

Solicitations@JCOD.lacounty.gov

If it is discovered that a Vendor contacted and received information from any County personnel, other than the person specified above, regarding this solicitation, County, in its sole determination, may disqualify their SOQ from further consideration."

2. **RFSQ, Section 5.0 NOTIFICATION TO VENDORS, Subsection 5.19, Prohibition from Participation in Future Solicitation(s)**, is deleted in its entirety and replaced with the following:

"5.19 Prohibition from Participation in Future Solicitation

A Proposer, or a Contractor, including but not limited to, its employees, contracted staff, subsidiaries or subcontractors ("Proposer/Contractor"), is prohibited from submitting a bid or proposal in a County solicitation if the Proposer/Contractor has provided and/or received advice or consultation for the solicitation. A Proposer/Contractor is also prohibited from submitting a bid or proposal in a County solicitation if the Proposer/Contractor has developed and/or prepared any of the solicitation materials on behalf of the County. A violation of this provision will result in the disqualification of the Proposer/Contractor from participation in the County solicitation or the termination or cancellation of any resultant County Contract or Work Order."

3. **RFSQ, Appendix A – SAMPLE MASTER AGREEMENT, Section 8.0 STANDARD TERMS AND CONDITIONS, Subsection 8.57, Prohibition from Participation in Future Solicitation(s)**, is deleted in its entirety and replaced with the following:

" 8.57 Prohibition from Participation in Future Solicitation(s)

A Proposer, or a Contractor, including but not limited to, its employees, contracted staff, subsidiaries or subcontractors ("Proposer/Contractor"), is prohibited from submitting a bid or proposal in a County solicitation if the Proposer/Contractor has provided and/or received advice or consultation for the solicitation. A Proposer/Contractor is also prohibited from submitting a bid or proposal in a County solicitation if the Proposer/Contractor has developed and/or prepared any of the solicitation materials on behalf of the County. A violation of this provision will result in the disqualification of the Proposer/Contractor from participation in the County solicitation or the termination or cancellation of any resultant County Contract or Work Order."

All other terms and conditions of this RFSQ remain in full force and effect.
