On March 21 2025, the County of Los Angeles (County) Department of Public Health (Public Health) released a Request for Statement of Qualifications (RFSQ) for Substance Use Supportive Services.

Pursuant to RFSQ Section 4.0, County Rights & Responsibilities, Public Health has the right to amend the RFSQ by written addendum. This Addendum Number 3 amends this RFSQ as indicated below (new RFSQ language in **highlight** and revised or deleted language in ~~strikethrough~~ for easy reference).

1. RFSQ, Section 1.0, Solicitation Information Timetable, is amended as follows:

Public Health will be continuously accepting SOQs throughout the duration of the Master Agreement to qualify additional Vendors and/or allow contractors to apply for additional categories. SOQs will be considered for review at the convenience of the County. Please note the County may at any time issue an addendum as described in Section 4.2 to close this RFSQ.

*The County will have the option to extend the term of the Master Agreements for five additional years through June 30, 2035. The five-year extension will be exercised at the sole discretion of Public Health.

2. RFSQ, Section 5.0, **NOTIFICATION TO VENDORS**, Sub-section 5.2, is amended as follows:

3. The revision contained in Addendum Number 2, and this Addendum Number 3, have been incorporated into the revised RFSQ dated February 2026, and made available as described below. All other terms and conditions of the RFSQ remain in full force and effect.
