ADDENDUM NUMBER SIXTEEN TO REQUEST FOR STATEMENT OF QUALIFICATIONS (RFSQ) #104569 FOR FACILITY ANCILLARY SERVICES MASTER AGREEMENT

Dear Proposers:

Q. As-Needed Asphalt Services:

- Vendor must hold the following valid and active licenses:
California General Engineering Contractors A License issued by the State License Board (CA-CSLB), C12- Earthwork and Paving, C32- Parking & Highway Improvements, D12- Synthetic Products Limited Specialty.
- Certification of Reported Compliance issues by the California Environmental Protection Agency for the Off-Road Diesel Fuel Vehicle Regulation.

3. Modify the following category under Sub-paragraph 2.7.2, Summary of Categories, Category III – General Services to include the following:

Q. As-Needed Asphalt Services

Provide As-Needed Asphalt Services. Services include but are not limited to commercial maintenance and repairs on asphalt services. This includes crack repairs, removal of asphalt/concrete, grading, compaction, installation of asphalt services as well as slurry seal coats and striping. In addition, purchasing of asphalt, road base, slurry coat, and paint; and meet the minimum requirements of sub-paragraph 1.4, Vendors Minimum Qualifications and Sub-paragraph 1.5, Specific Category Qualifications.

4. Delete Appendix A – Required Forms, Exhibit 1 – Statement of Qualifications Submittal Form in its entirety and replace with the attached Appendix A – Required Forms, exhibit 1 – Statement of Qualifications Submittal Form, updated July 30, 2025.

I. As-Needed Traffic Control Services

DESCRIPTION: Provide As-Needed Traffic Control Services. Services include, but are not limited to, traffic control activities in construction/maintenance and project zones in conjunction with County operations in the zone. Traffic Controllers shall be trained to perform, but not limited to, the following: 1. Traffic Controllers shall be utilized at County construction/maintenance sites where barricades and warning signs cannot adequately or safely control the flow of traffic through the site. 2. When traffic controls are required, they shall be placed in relation to the equipment or operation to give effective warning to traveling public of County's equipment and operations such that the public can safely move through the site. 3. Traffic Controllers shall be required to provide C28 stop/slow sign paddles and to wear warning garments such as vest, jackets, or shirts. These warning garments shall be either orange, strong yellow-green, or fluorescent versions of these colors. Traffic Controllers shall provide rain gear, which shall be orange, strong yellow-green or yellow. 4. During the hours of darkness, Traffic Controllers shall be outfitted with reflectorized garments. The reflective material shall be visible at a minimum distance of 1,000 feet. The reflective clothing, or the reflective material that meets the above requirements may be worn during hours of darkness in lieu of colored vests, jackets, and/or shirts. 5.
